NEW YORK STATE OFFICE OF THE MEDICAID INSPECTOR GENERAL - CERTIFICATE ADVISORY ALERT EFFECTIVE DECEMBER 1, 2010

The New York State Office of the Medicaid Inspector General (OMIG) has revised two online certification forms. This change is effective as of December 1, 2010.

Form CCSSL2010-1 - Certification of Compliance with the Social Service Law 363 –d and 18 NYCRR Part 521

- This form permits Medicaid providers to certify that their program is effective as required.
- A provider who does not have an effective program should not complete this form.

Form CCDRA2011-1 – Certification of Compliance with the Federal Deficit Reduction Act of 2005

- This form is to be used by New York State Medicaid providers who must certify that they are in compliance with the requirements of Federal Deficit Reduction Act of 2005 as it relates to the False Claim Act.
